

## Job Description

### Details of Post

- **Title:** Learning Support Assistant (Level 1)
- **School/ Federation/ Academy/Trust:** TrustEd Schools
- **Reporting to:** SENCO
- **Main Workplace:** Church Stretton School
- **Grade and SCP:** Grade 4 (SCP5)

*All support staff posts are subject to the Asylum and Immigration requirements*

### Purpose of Post

To provide intimate and personal care support (including changing and personal hygiene needs) to a female pupil in accordance with individual care plans.

Work under the instruction of the teaching staff and SENCO to support access to learning for pupils and to assist the teacher in the management of pupils and the classroom, including support for individual Education Health Care Plans (EHCP) and Personal Education Plans (PEPs). This will include the preparation and routine maintenance of resources / equipment. Work with pupils will be predominantly carried out in the classroom, or other suitable areas of the school building and, on occasion, at other locations where a curriculum visit is taking place.

### Principal Duties and Responsibilities

#### 1. Support for pupils

- To provide intimate and personal care support (including changing and personal hygiene needs) to a female pupil in accordance with individual care plans, maintaining the dignity, privacy and safety of the pupil at all times.
- Attend to pupils' personal needs, and implement related personal programmes, including social, health, physical, hygiene, first aid, and welfare matters.
- Supervise and support pupils, ensuring their safety and access to learning.
- Establish constructive relationships with pupils and interact with them according to individual needs.
- Promote the inclusion and acceptance of all pupils.
- Encourage pupils to interact with others and engage in activities led by the teacher.
- Encourage pupils to act independently as appropriate.

#### 2. Support for the teacher

- Prepare the classroom as directed for lessons and clear afterwards. Assist with the display of pupil's work.
- Ensure the timely and accurate preparation of routine equipment / materials as set out in instructions.
- Be aware of pupil problems / progress / achievements, and report to the teacher as agreed.
- Undertake pupil record keeping as directed.

- Support the teacher in managing pupil behaviour, reporting difficulties as appropriate.
- Supervising individual workstations or break out groups.
- Provide routine clerical tasks e.g. photocopying, typing, filing, collecting money etc.

### **3. Support for the curriculum**

- Support pupils in understanding instructions.
- Support pupils in respect of local and national learning strategies e.g. literacy, numeracy, KS3, early years etc. as directed by the teachers.
- Carry out individual or small group intervention.
- Support pupils in using basic ICT as directed.
- Prepare and maintain equipment / resources as directed by the teacher and assist pupils in their use.
- Monitor and arrange the orderly and secure storage of stock and supplies.

### **4. Support for the school**

- Be aware of and comply with policies and procedures relating to child protection, health, safety and security, confidentiality and data protection, reporting all concerns to an appropriate person.
- Be aware of and support difference and ensure that pupils have equal access to opportunities to learn and develop.
- Contribute to the overall ethos / work / aims of the school.
- Appreciate and support the role of other professionals.
- Attend and participate in relevant meetings as required.
- Participate in training and other learning activities and performance development as required.
- Assist with the supervision of pupils out of lesson times, including before and after school and at lunchtimes.
- Accompany teaching staff and pupils, as appropriate, on visits, trips, and out of school activities, and take responsibility for a group under the supervision of a teacher.

### **5. Other Responsibilities**

- Be aware of and comply with all school policies and procedures
- Be aware of and support difference and ensure equal opportunities for all
- Contribute to the overall ethos/work/aims of the school
- Appreciate and support the role of other professionals
- Attend and participate in relevant meetings as required
- Participate in training and other learning activities and performance development as required.

### **6. Safeguarding**

- Be aware of and comply with safeguarding responsibilities as outlined in the school's Staff Code of Conduct and related policies and procedures.

### **7. Data Protection and other statutory responsibilities**

- Be aware of and comply with data protection responsibilities as outlined in the school's Staff Code of Conduct and related policies and procedures.

### **8. Other Duties**

- Any other duties that the Headteacher, EHT/ CEO/ Governing Body/ Trustees feel is commensurate with the post. Whilst every effort is made to explain the main duties and responsibilities of the post each individual task undertaken may not be identified.
